## 2. Approval of TPO Priority Project List to be Submitted to TDOT and Area State Legislators Technical Committee Recommends Approval

**Item Summary:** Annually the TPO sponsors a meeting with our State legislators and TDOT administration to discuss our major transportation issues and projects.

Background: Attachment #2a - List of projects that the Technical Committee has recommended for approval.

## Attachment #2b - Discussion of mobility issues.

Jeff Welch stated the purpose of the priority project list is to advise TDOT and state legislators what the region's transportation priorities are. The project list includes both highway projects and public transit capital needs. A companion narrative discusses the mobility needs for non-highway facilities and programs.

A motion was made by Mayor Bill Haslam and seconded by Joe Hultquist to approve the priority project list to be submitted to TDOT and area State Legislators. The motion carried unanimously.

Chairman Mull states that due to budgetary issues a legislative luncheon will not be held this year.

## 3. Discussion of the Impact the Rescission Will Have on the TPO Area

**Presenter:** TPO Staff

**Item Summary:** Congress failed to repeal the rescission (required by previous acts of Congress, SAFETEA-LU and the Energy Independence and Security Act of 2007) that resulted in reducing the federal contract authority to states and urban areas by \$8.7 billion. As a result Tennessee had to return approximately \$190 million of transportation funding. The Knoxville area stands to lose approximately \$8.3 million of STP funds, \$5 million of CMAQ funds and \$700,000 of MPO planning funds.

# Attachment #3 - Letter from Paul Degges, TDOT, outlining final rescission amount for the Surface Transportation Program and discussing related issues.

Jeff Welch stated that the final rescission figures show a reduction in STP funds by \$8.2 million. There is a balance \$19 million for the TPO area. Because of the loss of funds, projects have been put on hold. Other funds have been rescinded including Congestion Mitigation and Air Quality and planning program dollars.

Currently federal transportation funds are being distributed under a continuing resolution, so we cannot flex money from the highway fund to the transit fund to assist our transit partners. The Transportation Improvement Program will need to be amended in early 2010 to reflect this loss of CMAQ and STP dollars.

Jeanne Stevens of TDOT stated that Knoxville has done a good job of spending down STP money. She said that TDOT may be able to provide some CMAQ funding and would want to see the funds for the projects obligated by September 2010.

## 4. Letter regarding Chapman Highway (US 441) in Blount, Knox and Sevier Counties

**Presenter:** TPO Staff

**Item Summary:** The TPO received a copy of a letter from State Sen. Jamie Woodson to TDOT Commissioner Gerald Nicely requesting improvements to Chapman Highway to ensure the safety of those traveling this state highway. In 2007 a Chapman Highway Corridor Improvement Study was completed by a consultant for TDOT. This study recommended a number of short-term traffic solutions that would improve safety and facilitate traffic flow throughout the corridor.

Attachment # 4 - Copy of Letter from State Sen. Jamie Woodson

Jeff Welch stated that State Sen. Woodson sent a letter to Commissioner Nicely regarding the Chapman Highway Corridor Improvement Study. She supports improving safety on Highway 441 (Chapman Highway) in Sevier and Knox County. TPO and local governments needs to identify priority projects along Chapman Highway.
