Attachment #2A - Amendment 2014-052 (Tazewell Pk. (SR-331) and Emory Rd. (SR-131) Intersection Improvements) - Amend the project by increasing STP funding in FY 2014 for construction from \$2,600,000 total (\$2,080,000 federal and \$520,000 state) by adding \$2,400,000 for a new total of \$5,000,000 (\$4,000,000 federal and \$1,000,000 state) at the request of TDOT. Amend the total project cost from \$4,164,000 to \$7,142,700.

<u>Attachment #2B - Amendment 2014-072 (Alcoa Sidewalk/Greenway Extension)</u> - Amend the project by adding it to the 2014-2017 TIP. The project will add Enhancement funding for construction in FY 2015 in the amount of \$849,978 total (\$679,982 federal and \$169,996 local) for the extension of the existing Alcoa greenway by 1.6 miles along N. Wright Rd. This is a TDOT Enhancement Grant award.

**Item Summary:** TDOT is accepting applications for its TAP funding through Nov. 3. For projects within the TPO planning area, TDOT requires that we review the application before submittal. We will need to receive draft applications by Oct. 20. TPO endorsement of applications prior to submittal to TDOT is optional. Any local government that wants the TPO to endorse its application before submittal should contact TPO staff by Oct. 3.
