Attachment #2A - Amendment 2014-032 (South Knoxville Waterfront Roadway Improvements) – Amend project by revising the project description to: "The project consists of roadway streetscape improvements to Sevier Ave. consisting of new/improved curbs and sidewalks, bike lanes, planters, pavement marking for on-street parallel parking, utility placement, and handicap access improvements. No additional lanes will be constructed. A roundabout will be constructed at the intersection of Foggy Bottom/Sevier Ave./Island Home Ave." Amend the termini to: "Sevier Ave. from Davenport Rd. to new roundabout at Island Home Ave. (0.32 miles)". Amend the project length from 0.8 miles to 0.32 miles.

Attachment #2B - Amendment 2014-033 (Chapman Hwy. (SR-71) Improvements) – Amend project by adding FY 2017 Construction phase in the amount of \$9,200,000 (\$7,360,000 federal NHPP funds/\$1,840,000 state match). Increase total project cost to \$18,185,200.

Attachment #2C - Amendment 2014-034 (Intersection of SR-73(US-321) and SR-2(US-11)) – Amend project by reducing the amount programmed for FY 2017 Construction phase by \$14,000,000 (\$11,200,000 federal NHPP funds/\$2,800,000 state match). Decrease total project cost to \$17,405,000. Include project length of 0.13 miles.
