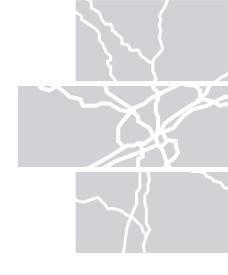

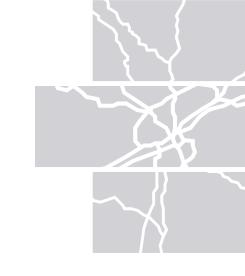

Project Call for Existing and New TPO Funded Projects

- 22 new applications received
 - \$72.7M in new L-STBG requested (18 projects)
 - \$3.8M in new L-STBG-TA requested (2 projects)
 - \$0 in new CRP requested
 - \$2.4M in CMAQ PM2.5 requested (2 projects)
- 38 existing project rollover applications
 - \$108.6 M L-STBG requested
 - \$62.5M carryover costs
 - \$46.0M new costs (cost increase, or a new phase request)
 - \$10.1 L-STBG-TA requested (\$4.0M carryover/\$6.1M new)
 - \$3.0M CRP requested (\$1.8M carryover/\$1.2M new)
 - \$17.3M CMAQ PM2.5 requested (\$4.7M carryover/\$12.6M new)
- 8 existing CMAQ project rollover applications

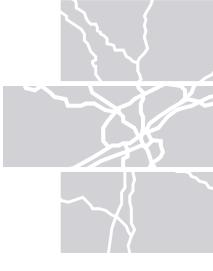

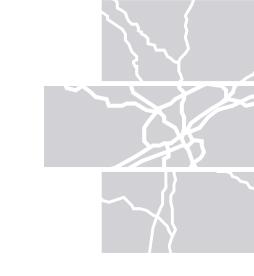

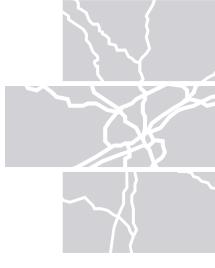


Looking Ahead
