3. Overview of the Draft 2017-2020 Transportation Improvement Program (TIP)

Item Summary: The FY 2017-2020 TIP is being updated in two separate phases due to the need for alignment with the schedule for the update of the TPO's Mobility Plan 2040. The first phase of the FY 2017-2020 TIP is represented in this document and consists only of a direct carry-over of projects from the previous FY 2014-2017 TIP that have phases of work which have not yet had funding obligated.

The second phase of the FY 2017-2020 TIP will be completed in Spring 2017 and will coincide directly with the adoption of the Mobility Plan 2040, which is the Long Range Transportation Plan for the Knoxville Region.
