Sub-Committee Process, Application Review, and Recommendations

The TPO advertised the Section 5310 call-for-projects starting on March 26, 2023. The notice was posted on the TPO website, advertised in the regional newspapers, and sent to the TPO's 5310 interested agency database. Applications were due April 21, 2023. The TPO received eight applications. For this round, we had one new agency, Community Options, apply for funding. The other seven applicants have previously received funding from the TPO and all are in good standing as far as meeting federal, state, and TPO requirements. The TPO staff regularly reviews the status of approved projects and makes sure agencies are in compliance with both federal and state regulations.

When the applications were reviewed, the sub-committee was able to make a recommendation to fund all of them, except one, completely. The one exception, Community Options, is recommended to receive approximately 65% of the funding they requested. Community Options had asked for four non-accessible SUVs. However, FTA regulations state that agencies can only receive non-accessible vehicles if they can demonstrate that they have accessible vehicles available to them, on a regular basis, in their fleet. Community Options, in Maryville, does not have any accessible vehicles. So, the sub-committee awarded them funding to purchase one wheelchair accessible minivan and one SUV. Community Options has agreed to this modification of their application.

Another applicant is the Sevier County LIVE-IT program. LIVE-IT is a volunteer assisted transportation program that has previously received funding from the TPO. It is important to note that the services provided by the LIVE-IT are partially outside the TPO's planning area. LIVE-IT is headquartered and a majority of their clients live in Seymour, in Sevier County, which is in the current planning area. However, from time-to-time, the Program will have clients and/or trips that will be made in portions of Sevier County outside the TPO's planning area. This will be the last round of funding in which LIVE-IT will be able to apply for through the TPO, as Seymour has fallen out of the urbanized area based on the 2020 Census. The FTA has ruled that the new urban boundaries go into effect starting with Fiscal Year 2024 funding. The funding the TPO is awarding is from Fiscal Year 2022 and 2023. As some of the LIVE-IT services are provided outside the TPO's planning area, the TPO Executive Board (according to their bylaws) must approve this project by 2/3 vote.

In all, the sub-committee recommends approving projects in the amount of \$1,288,433 in federal funds. See Table One for the agencies funded, the specific projects, and dollar amounts. All projects (except administration) require some form of local match. Operating projects are funded at 50% federal funding and require a 50% local match. Capital projects are funded at 80% federal funding and require a 20% local match. Typically, the Tennessee Department of Transportation (TDOT) provides half of the local match. So, the breakdown for operating projects would be 50% federal, 25% TDOT, and 25% local match and for capital projects the breakdown would be 80% federal, 10% TDOT, and 10% local match. Administration is 100% federal funding and does not require a match.

The TPO Technical Committee and Executive Board are essentially approving the FTA (federal) funding only. While TDOT traditionally participates by providing half of the local match that decision does not occur until the TPO can submit a match request application with an approved FTA grant. The TPO cannot seek an FTA grant without prior approval of the Program of Projects by the Executive Board and having the projects added through an adjustment into the Transportation Improvement Program (TIP). If, for some reason, TDOT does not participate in the local match, the local agency is required to provide all of the local match.
