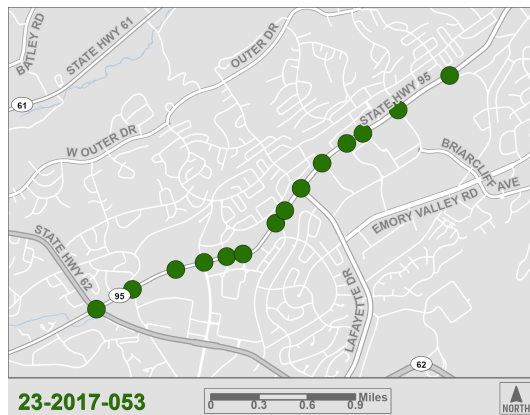

Air Quality Conformity Status:

This amendment does not trigger the need for a conformity determination because the projects/actions have been determined to be Exempt from the need to demonstrate conformity as per 40 CFR 93.126 or are Exempt from regional emissions analyses as per 40 CFR 93.127.

Metropolitan Transportation Planning Process Certification:

The Knoxville TPO Planning Process certification is included and certifies that every four years the transportation planning process addresses the major issues in the metropolitan planning area and is conducted in accordance with all applicable requirements.

Resolution:

The adopting resolution for these projects and air quality conformity determination is included.

Public Participation:

Public participation processes were in accordance with the Knoxville TPO's federally approved Public Participation Plan. Two public hearings were held on June 13, 2023 at the TPO Technical Committee Meeting, followed by June 28, 2023 at the TPO Executive Board meeting. No public comments were received.

Interagency Consultation:

The Knoxville Air Quality Interagency Consultation (IAC) group was consulted on June 8, 2023 regarding the conformity exempt status of the amendment. There was agreement from the group regarding the Knoxville TPO staff's exempt assessment of the projects based on IAC correspondence. The required 14-day IAC review period was from June 8, 2023 to June 22, 2023. IAC email correspondence regarding the amendments is included.

Dear Mr. Meservy:

The Federal Highway Administration (FHWA) Tennessee Division and Federal Transit Administration (FTA) Region IV Office, in coordination with the Environmental Protection Agency (EPA) Region IV Office, have reviewed the Air Quality Conformity Determination adopted by the Knoxville Regional Transportation Planning Organization (KRTPO) Executive Board on October 26, 2022 and the Lakeway Area Metropolitan Transportation Planning Organization (LAMTPO) Executive Board on November 9, 2022.

The Air Quality Conformity Determination covers the Knoxville, Tennessee maintenance area for the 1997 and 2008 8-hour ozone and the 2006 Daily PM_{2.5} National Ambient Air Quality Standards (NAAQS) and addresses the planned transportation improvements from the KRTPO's amended 2045 Metropolitan Transportation Plan (MTP), the new FY 2023–2026 Transportation Improvement Programs (TIPs) for the Knoxville Regional TPO and Lakeway MTPO planning areas, and the portions of the State of Tennessee's Statewide TIP in the Knoxville, Tennessee maintenance area.

Based on our review, we find the documents conform to the ozone and PM_{2.5} NAAQS for Knoxville, Tennessee.

**A RESOLUTION BY THE EXECUTIVE BOARD
OF THE KNOXVILLE REGIONAL
TRANSPORTATION PLANNING ORGANIZATION (TPO)
AMENDING THE FY 2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM**

WHEREAS, the FY 2023-2026 Knoxville Regional Transportation Improvement Program was adopted on October 26, 2022; and

WHEREAS, in accordance with requirements of the U.S. Department of Transportation, the elements of the transportation planning process are to receive final approval from the Executive Board of the local Metropolitan Planning Organization; and

WHEREAS, the Transportation Improvement Program must be updated as needed; and

WHEREAS, the proposed project amendments were reviewed with the Knoxville-Area Air Quality Interagency Consultation Group with respect to air quality conformity requirements and are either exempt from, or were demonstrated to conform with the federal transportation air quality conformity regulations from the Clean Air Act; and

WHEREAS, a short conformity determination report was prepared for the air quality non-exempt project amendments which concluded that air quality conformity was demonstrated by relying on a previous regional emissions analysis; and

WHEREAS, the Knoxville Regional Transportation Planning Organization Technical Committee recommends approval of the Resolution, and

NOW, THEREFORE, BE IT RESOLVED BY THE KNOXVILLE REGIONAL TRANSPORTATION PLANNING ORGANIZATION EXECUTIVE BOARD;

That the FY 2023-2026 Transportation Improvement Program be amended to include the following changes and that the Tennessee Department of Transportation include these amendments into the State Transportation Improvement Program:





Knoxville IAC Members,

The Knoxville Regional TPO Executive Board will be hearing two amendments to the FY 2023-2026 TIP (pending its final approval) at their June 28, 2023 meeting. Following is a brief description of the projects included in this amendment and attached is a packet with the before/after profile pages and financial tables to demonstrate fiscal constraint.

1.) Amendment 23-2017-053 (Oak Ridge Signal Timing Optimization, Ph. 2) - Amend the TIP to add this exempt project for construction in FY 2023. Construction is estimated at \$2,573,400 (100% federal S-CRP [Y607]). This amendment adds \$2,573,400 (\$2,573,400 federal S-CRP/\$0 local) to the TIP. The total project cost is unchanged at \$2,855,400. This project needs to be rolled into the new FY 2023-2026 TIP since it did not meet the expected timeline of having construction funds obligated during the period of the FY 2020-2023 TIP and its funding source is being swapped from CMAQ to the newly established Carbon Reduction Program (CRP) from IIJA. The project was previously determined to be Exempt and no changes to its description and scope are being made.

2.) Amendment 23-2023-308 (Travel Congestion and Clean Air Improvement Grouping) - Amend the TIP to add this exempt grouping. This grouping will include locally sponsored projects to reduce traffic congestion and improve air quality throughout the Knoxville TPO planning area. The grouping initially contains funding for two projects in fiscal year 2023:

- Knoxville Area Transit (KAT): Electric Vehicle Charging Infrastructure – The KAT Electric Vehicle Infrastructure project includes in-route overhead charging infrastructure at the Knoxville Station and at up to three KAT's superstops. Purchase and installation is programmed in FY 2023 at an estimated cost of \$7,500,000 CMAQ PM2.5 (\$6,000,000 federal/\$1,500,000 local). This is a continuation and addition of funding for a previous CMAQ-funded project (ID# 20-2020-207) to enable KAT to implement electric buses, which was also previously determined to be Exempt from conformity.
- Knoxville Regional TPO: School Congestion Reduction Program – Education & Outreach program to reduce congestion and emissions around schools by encouraging alternative modes of travel to and from school, and by promoting remote pick-up and drop-off sites. Planning and implementation is programmed in FY 2023 at a cost of \$25,000 CMAQ PM2.5 (\$20,000 federal/\$5,000 local). This project resulted from repurposing funding originally programmed for bike rack installation and involves only planning and outreach activities.

In summary, it is the TPO staff's opinion that the above listed proposed TIP amendments do not trigger the need for a conformity determination because this project/action is exempt from conformity for the reasons noted above. Also, the TPO staff have determined that the project amendment meets financial constraint requirements. Please review this information and provide any comments regarding air quality conformity implications or let me know if you have any questions or need further clarification on any of the projects. If I do not hear anything within two (2) weeks (**by Thursday, June 22, 2023**) we will assume that you concur that these amendments are exempt from transportation conformity.
