INTRODUCTION

The 2025 Annual Listing of Obligated Projects Report for the Knoxville Regional Transportation Planning Organization (TPO) is an analysis of the projects for which federal transportation

funds were obligated in the Knoxville region in fiscal year 2025 (October 1, 2024 through September 30, 2025).

The report serves as an annual summary and evaluation tool for projects programmed in the 2023-2026 Transportation Improvement Program (TIP) or prior TIP's. By compiling a list of projects for which funds were obligated in FY 2025 and identifying which projects had FY 2025 programmed funds that went unobligated, the TPO is better equipped to monitor the region's overall success at implementing projects.

An obligation does not necessarily mean that the phase of work (e.g., construction) was initiated or completed in the program year. Also, the amount of the obligation may not equal the total cost of the project.

The list of obligated projects is made available by the cooperative effort of the State, transit operators, and the TPO. The Infrastructure Investment and Jobs Act (IIJA), also known as the Bipartisan Infrastructure Law, and associated regulations (23 CFR 450.334) requires the report be produced annually.

KNOXVILLE REGIONAL TPO

The Knoxville Regional Transportation Planning Organization (TPO) is the federally designated Metropolitan Planning Organization (MPO) required to carry out transportation planning in the TPO planning area. This area is based on the federally designated Knoxville Urbanized Area (UZA) that includes several jurisdictions, namely the City of Knoxville, Knox County, and parts of Anderson, Blount, Loudon, and Sevier Counties. The Knoxville Regional TPO Planning Area encompasses the existing Knoxville UZA, along with contiguous area expected to be urbanized within 20-years. The planning area largely determines where TPO managed federal funds can be spent.




Figure 1 Map of 2020 Urbanized Areas and Knoxville TPO Planning Area

TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

The TIP is a four-year work program of all regionally significant and federally funded transportation projects, programs, and transportation services within the planning area. It's also important to note the relationship between the TIP and the Mobility Plan, Knoxville Region's long range transportation plan, as the TIP is a subset of the Mobility Plan. The Mobility Plan outlines long range goals and projects in the Knoxville Region over a 20+ year period. The FY 2023-2026 TIP is essentially the first four years of the Mobility Plan and contributes to the achievement of long-term transportation objectives.

TIP projects are consistent with federal transportation regulations and accordingly, all TIP projects become part of TDOT's State Transportation Improvement Program. These projects are financially constrained and implementable in the near term. The TIP is amended and administratively modified periodically to add new projects, delete projects, change funding amounts and fiscal years, etc.

OBLIGATIONS


Two important terms are programmed funds and obligated funds. Programmed funds are funds that have been identified in the TIP for a project and phase. Obligated funds are funds that are committed to the project phase by the Federal government.



Programming funds is like writing a check. The funds for the project phase are considered obligated when the check is cashed.

Transportation Project Funding Process

The flow chart below identifies the transportation project funding process. It starts with setting policy and planning then ends with the local project sponsor being reimbursed by the Federal government.



Obligations History (Fiscal Years 2016-2025)




Figure 2 Knoxville TPO Obligation History FY 2016 - FY2025

In fiscal year 2025, \$162.0 million in federal funds were programmed to 40 transportation projects and groupings in the current FY 2023-2026 TIP. Obligations totaled \$133.4 million to 50 projects and groupings, which included 27 projects from previous TIPs and/or STIPs and 23 projects from the current 2023-2026 TIP (Figure 2).

To ensure effective use of federal funds, the Knoxville Region strives to obligate as much of the programmed federal funds as possible. The gray area between the lines in Figure 2 shows the difference between programmed and obligated funds. In 2025, the region obligated 82% of programmed funds. This obligation rate is higher than historical average, though does represent a decline from the previous two years of obligations exceeding programmed amounts.

Notable obligations include \$36.3M to the I-75 interchange at SR-131 (Emory Road) project, \$21.3M for Knoxville Area Transit (KAT) Operating and Capital expenditures, \$20.9M to the National Highway System Preservation and Operation Grouping, \$12.7M to the Surface Transportation System Preservation and Operation Grouping, \$12.1M to the Pleasant Ridge Road widening project, \$10.7M to the Alcoa Highway (SR-115/US-129) — Woodson Drive to near Cherokee Trail Interchange project, and \$6.6M to KAT Electric Bus Purchases. 91 percent of all obligated funds were due to these significant projects.

Challenges to Timely Obligations

Performance measures are necessary to make wise investment and policy decisions on how we achieve regional, state, and national transportation goals. The percentage of funds obligated for each fiscal year of total funds available for obligation is indicative of how well the Knoxville Region is utilizing transportation funds.

The Knoxville Region strives to obligate 100% of programmed dollars. However, there are obstacles that make achieving the 100% goal difficult. Acknowledging these challenges can aid in developing strategies to maximize obligations. Hurdles to obligating project phases include:

- Bids that are over budget
- Capacity to navigate approval process
- Number of projects exceed local sponsor capacity
- Project delays

In an effort to facilitate timely obligation of funds, project tracking meetings with local agencies were initiated in FY 2018. Regular collaboration between state and local partners

continue to provide an opportunity to address project development challenges and promote on time project delivery.

SUMMARY OF FY 2025 OBLIGATED PROJECTS

Obligations by Programming Authority

Programmed authority refers to an Agency's responsibility to determine which projects will receive federal funds. Congress delegates the programming authority of federal funds to State DOTs and MPOs. In 2025, the TPO's programming authority was \$79.8 million in Surface Transportation Block Grant (STBG) funds, and \$6.3 million in Surface Transportation Block Grant Transportation Alternatives Program (STBG-TA) funds, and \$6.2 million in Carbon Reduction Program (CRP) funds. Tennessee Department of Transportation (TDOT) manages the remaining federal funds.

Federal transit funding comes to the urban area several different ways. For the Federal Transit Administration (FTA) Section 5307 Urban Area and Section 5339 Bus and Bus Facilities funding, the City of Knoxville is the Designated Recipient and determines how that funding is distributed. Section 5307 funding is divided based on an agreed upon formula between KAT, Knox County CAC Transit, and ETHRA. The TPO is the Designated Recipient of FTA Section 5310 Enhanced Mobility for Seniors and Individuals with Disabilities funding.




Figure 3 Knoxville Region FY 2024 Obligations by Programming Authority

In 2025, \$133.4 million in federal funds for roadway, bike/pedestrian and public transportation projects was obligated in the TPO Planning Area. TDOT authorized \$84.9M, or 64 percent, of the funds. TPO FHWA obligations of \$18.8M represented 14 percent, with TPO direct funds (\$23.1M/17%)

and TPO derived FTA funds (\$6.6M/5%) comprising the remaining balance (Figure 3).

Obligations by System Type

Knoxville's transportation system is comprised of interstates, state and local routes, bicycle and pedestrian facilities, transit services, and technologies that improve the transportation system. Examples of these technologies and programs include intelligent transportation systems, ridesharing programs, traffic signalization projects, etc. In 2025, the largest amount of obligated funds was to Interstate Route projects (40.4%, 7 projects). Table 1 reflects obligations by system type.

Obligations by Fund Source

The federal government provides multiple funding sources for the construction and preservation of state and local transportation infrastructure. The types of projects vary from new roadways, widening of existing roadways, intersection improvements, bridges, and general roadway maintenance. Other projects covered under federal funding are bicycle, pedestrian, and transit.

The National Highway Performance Program (NHPP) represented the largest share of obligations in 2025, with \$55.2M representing 41.4% of the total. FTA transit program funding, at \$23.1M and 17.3% of total obligations was the next most prominent source followed by state and local STBG obligations at \$24.4 (18.3%). The Surface Transportation Block Grant Program (STBG) promotes flexibility in state and local transportation decisions and provides flexible funding to best address state and local transportation needs. NHPP funds are used by States to provide support for the condition and performance of the National Highway System through activities such as construction, reconstruction, resurfacing, preservation, and operational improvements. Table 2 illustrates 2025 federal fund obligations by funding source.

The remaining funding sources are Congestion Mitigation and Air Quality (CMAQ), Carbon Reduction Program (CRP), Federal Lands Access Program (FLAP), Highway Infrastructure Program (HIP), High Priority Project (HPP) Highway Safety Improvement Program (HSIP), Highway Safety Improvement Program Rail (HSIP-R), Penalty Highway Safety Improvement Program (PHSIP), Local Surface Transportation Block Grant - Transportation Alternatives (L-STBG-TA), National Highway System (NHS), State Surface Transportation Block Grant - Transportation Alternatives (S-STBG-TA), and State Surface Transportation Block Grant (S-STBG).

TPO Regionally Managed Funds

The TPO is particularly interested in the performance of regionally managed federal funds. Each year the Knoxville region is allocated L-STBG, L-STBG-TA, and L-CRP funds to fund projects that best fit the region's priorities and goals. These funds are distributed to projects in the Knoxville region by the TPO Executive Board through a competitive process. In 2025, 218% of programmed L-CRP funds, 46% of programmed L-STBG funds and 24% of programmed L-STBG-TA funds were obligated. (Table 3).

De-obligated funds

Depending on the source of funding, de-obligated funds are returned to the FTA, FHWA, TDOT, or TPO. De-obligated funds that are returned to FHWA, FTA, or TDOT are unlikely to be reprogrammed on other projects within the Knoxville Region.

De-obligations of regionally managed federal funds are returned to TPO if they remain available and may be reprogrammed to other projects within the Knoxville Region. Among TPO managed funds, only L-STBG funds had de-obligations in 2025. A total of \$24,793 L-STBG was returned to the TPO. (Table 4).

Closed projects

The final stage of project delivery is the project close out process. After a project is completed the close out process wraps up any final reimbursements and officially closes the project. If a project has come in under budget, some deobligations of federal funds may occur during close out. In 2025, 8 projects were closed and \$4.9 million in federal funds de-obligated.
